Inflatable Rules and Safety Requirements

Rental Requirements

1. Inflatable must be in a location where it can be staked to the ground. Area must be clear of underground utilities (sprinklers, electrical, etc.)
2. Weather conditions must be acceptable for inflatable use. Temperatures must be above 40 degrees F, no rain; winds must not exceed 15 MPH, no thunder or lightning.
3. Inflatables which require one blower will require a 15 amp circuit dedicated to the blower. Two blower inflatables will require two 15 amp circuits or one 20 amp circuit.
4. We will provide enough extension cord to reach 50 feet from the electrical source. If electricity will be located further away than this, a generator will be needed to operate the inflatable.
5. A responsible adult must be identified at the time of setup who will be responsible for supervising the inflatable during use.
6. Setup area must be dry and either grass or sound concrete or asphalt. Rocky or gravel drives can damage the unit.

Safety Rules:

1. The blower should be left running continuously until you are finished with the unit and wish to deflate it.
2. Most inflatables are designed for use by children. Please follow the size and number restrictions on each inflatable.
3. Always group children by size, larger children can easily injure smaller children in the inflatable.
4. **Always remove shoes** before using the inflatable.
5. Remove all sharp or hard-edged objects, such as glasses, jewelry, watches, shoes, casts, etc., before using the inflatable. Remove all items from pockets.
6. No flips, somersaults or body slamming is allowed.
7. Jumping is only allowed inside the area enclosed by the safety netting. Do not jump on the loading platform.
8. **Food, drink, gum, candy, etc., are choking hazards and therefore are not permitted while using the inflatable.**
9. Do not allow children to play near the blowers or behind the unit at any time.
10. All entry zippers and Velcro should be closed if applicable.
11. If the blower(s) lose power, or shut down for any reason, all users should exit the inflatable immediately until power is restored.
12. Except on units identified as wet inflatables, **no water should come in contact with the unit.** Non water inflatables are not designed for the speeds riders will attain on a wet ride. Consequently, injuries or damage to the unit can occur from using water on the inflatable.

13. If the weather becomes dangerous during operation of the unit, all users should leave the unit and the blowers should be shut down. **DO NOT** use inflatables in inclement weather.

Rental Rules

1. All safety rules must be followed at all times.
2. **Inflatable unit must be kept clean and dry.** If the inflatable is wet or dirty when it is picked up, a \$50 cleaning charge may be assessed. (Cleaning fees are not assessed for moisture from rain or dew).
3. Renter is responsible for ensuring that a responsible adult is supervising the inflatable during use.
4. Inflatable must remain staked during the entire rental period.
5. Blowers must be turned off and unplugged if inclement weather is experienced (rain, hail, strong winds, thunder, or lightning).
